4. Review/Endorse South Florida Avenue (State Road 37) Master Plan

FDOT staff will provide an overview of the South Florida Avenue (SR 37) Master Plan which addresses a 1.4 mile segment of SR 37 from Ariana Street to Pine Street in Lakeland. Staff will request the committee to endorse the plan as consistent with the TPO's adopted Complete Street Policy and to provide related recommendations. Action is requested. (Attachments)

5. Future Widening of US 98 from Lakeland to US 301 (Pasco County)

The four-lane widening of this segment of US 98 is an unfunded need in both the Pasco MPO and Polk TPO long range transportation plans.
